A BILL

Making appropriations for the Department of Homeland Security and other purposes for the fiscal year ending September 30, 2026, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 fiscal year ending September 30, 2026.

1 TITLE I
2 DEPARTMENTAL MANAGEMENT, INTEL-
3 LIGENCE, SITUATIONAL AWARENESS, AND
4 OVERSIGHT
5 OFFICE OF THE SECRETARY AND EXECUTIVE
6 MANAGEMENT
7 OPERATIONS AND SUPPORT

8 For necessary expenses of the Office of the Secretary
9 and for executive management for operations and support,
10 \$297,584,000, which shall be for the purposes and in the
11 amounts specified in the “Final Bill” column for Office
12 of the Secretary and Executive Management, Operations
13 and Support, in the “Department of Homeland Security
14 Appropriations Act, 2026” table in the explanatory state-
15 ment described in section 553 of this Act, except that the
16 amount specified for “Office of the Secretary” in such col-
17 umn shall be deemed to be amended by striking “18,711”
18 and inserting “0”: *Provided*, That \$14,050,000 of
19 amounts made available for Management and Oversight,
20 Office of Health Security and \$8,000,000 of amounts
21 made available for Office of Strategy, Policy, and Plans
22 shall remain available until September 30, 2027: *Provided*
23 *further*, That \$5,000,000 shall be withheld from obligation
24 until the Secretary submits to the Committees on Appro-
25 priations of the House of Representatives and the Senate

1 responses to all questions for the record for each hearing
2 on the fiscal year 2027 budget submission for the Depart-
3 ment of Homeland Security held by such Committees prior
4 to July 1: *Provided further*, That not to exceed \$15,000
5 shall be for official reception and representation expenses.

6 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

7 For necessary expenses of the Office of the Secretary
8 and for executive management for procurement, construc-
9 tion, and improvements, \$8,911,000, to remain available
10 until September 30, 2028.

11 MANAGEMENT DIRECTORATE

12 OPERATIONS AND SUPPORT

13 For necessary expenses of the Management Direc-
14 torate for operations and support, including vehicle fleet
15 modernization, \$1,690,380,000, which shall be for the
16 purposes and in the amounts specified in the “Final Bill”
17 column for Management Directorate, Operations and Sup-
18 port, in the “Department of Homeland Security Appro-
19 priations Act, 2026” table in the explanatory statement
20 described in section 553 of this Act: *Provided*, That not
21 to exceed \$2,000 shall be for official reception and rep-
22 resentation expenses.

23 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

24 For necessary expenses of the Management Direc-
25 torate for procurement, construction, and improvements,

1 \$58,106,000, to remain available until September 30,
2 2028.

3 FEDERAL PROTECTIVE SERVICE

4 The revenues and collections of security fees credited
5 to this account shall be available until expended for nec-
6 essary expenses related to the protection of federally
7 owned and leased buildings and for the operations of the
8 Federal Protective Service.

9 INTELLIGENCE, ANALYSIS, AND SITUATIONAL
10 AWARENESS

11 OPERATIONS AND SUPPORT

12 For necessary expenses of the Office of Intelligence
13 and Analysis and the Office of Homeland Security Situa-
14 tional Awareness for operations and support,
15 \$340,819,000, of which \$121,274,000 shall remain avail-
16 able until September 30, 2027: *Provided*, That not to ex-
17 ceed \$3,825 shall for be official reception and representa-
18 tion expenses and not to exceed \$2,000,000 is available
19 for facility needs associated with secure space at fusion
20 centers, including improvements to buildings.

21 OFFICE OF INSPECTOR GENERAL

22 OPERATIONS AND SUPPORT

23 For necessary expenses of the Office of Inspector
24 General for operations and support, \$257,599,000, of
25 which \$20,000,000 shall be for additional inspections and

1 oversight of detention facilities and shall remain available
2 until September 30, 2027, and of which \$12,814,000 shall
3 be for oversight of the execution of funds provided in Pub-
4 lic Law 119–21: *Provided*, That not to exceed \$300,000
5 may be used for certain confidential operational expenses,
6 including the payment of informants, to be expended at
7 the direction of the Inspector General.

8 ADMINISTRATIVE PROVISIONS

9 SEC. 101. (a) The Secretary of Homeland Security
10 shall submit a report not later than October 15, 2026,
11 to the Inspector General of the Department of Homeland
12 Security listing all grants and contracts awarded by any
13 means other than full and open competition during fiscal
14 years 2025 or 2026.

15 (b) The Inspector General shall review the report re-
16 quired by subsection (a) to assess departmental compli-
17 ance with applicable laws and regulations and report the
18 results of that review to the Committees on Appropriations
19 of the House of Representatives and the Senate not later
20 than February 15, 2027.

21 SEC. 102. (a) Not later than 30 days after the last
22 day of each month, the Chief Financial Officer of the De-
23 partment of Homeland Security shall submit to the Com-
24 mittees on Appropriations of the House of Representatives
25 and the Senate a monthly budget and staffing report that

1 includes total obligations of the Department for that
2 month and for the fiscal year at the appropriation and
3 program, project, and activity levels, by the source year
4 of the appropriation.

5 (b) The initial staffing report submitted pursuant to
6 subsection (a) shall be the baseline for which the Depart-
7 ment of Homeland Security may increase or decrease
8 staffing levels for any program, project, or activity pursu-
9 ant to section 503(a)(4) of this Act.

10 SEC. 103. (a) The Secretary of Homeland Security,
11 in consultation with the Secretary of the Treasury, shall
12 notify the Committees on Appropriations of the House of
13 Representatives and the Senate of any proposed transfers
14 of funds available under section 9705(g)(4)(B) of title 31,
15 United States Code, from the Department of the Treasury
16 Forfeiture Fund to any agency within the Department of
17 Homeland Security.

18 (b) None of the funds identified for such a transfer
19 may be obligated until the Committees on Appropriations
20 of the House of Representatives and the Senate are noti-
21 fied of the proposed transfer.

22 SEC. 104. All official costs associated with the use
23 of Government aircraft by Department of Homeland Secu-
24 rity personnel to support official travel of the Secretary

1 and the Deputy Secretary shall be paid from amounts
2 made available for the Office of the Secretary.

3 SEC. 105. (a) The Under Secretary for Management
4 shall brief the Committees on Appropriations of the House
5 of Representatives and the Senate not later than 45 days
6 after the end of each fiscal quarter on all Level 1 and
7 Level 2 acquisition programs on the Master Acquisition
8 Oversight List between Acquisition Decision Event and
9 Full Operational Capability, including programs that have
10 been removed from such list during the preceding quarter.

11 (b) For each such program, the briefing described in
12 subsection (a) shall include—

13 (1) a description of the purpose of the program,
14 including the capabilities being acquired and the
15 component(s) sponsoring the acquisition;

16 (2) the total number of units, as appropriate, to
17 be acquired annually until procurement is complete
18 under the current acquisition program baseline;

19 (3) the Acquisition Review Board status, in-
20 cluding—

21 (A) the current acquisition phase by incre-
22 ment, as applicable;

23 (B) the date of the most recent review; and

24 (C) whether the program has been paused
25 or is in breach status;

1 (4) a comparison between the initial Depart-
2 ment-approved acquisition program baseline cost,
3 schedule, and performance thresholds and objectives
4 and the program's current such thresholds and ob-
5 jectives, if applicable;

6 (5) the lifecycle cost estimate, adjusted for com-
7 parison to the Future Years Homeland Security
8 Program, including—

9 (A) the confidence level for the estimate;

10 (B) the fiscal years included in the esti-
11 mate;

12 (C) a breakout of the estimate for the
13 prior five years, the current year, and the budg-
14 et year;

15 (D) a breakout of the estimate by appro-
16 priation account or other funding source; and

17 (E) a description of and rationale for any
18 changes to the estimate as compared to the pre-
19 viously approved baseline, as applicable, and
20 during the prior fiscal year;

21 (6) a summary of the findings of any inde-
22 pendent verification and validation of the items to be
23 acquired or an explanation for why no such
24 verification and validation has been performed;

1 (7) a table displaying the obligation of all pro-
2 gram funds by prior fiscal year, the estimated obli-
3 gation of funds for the current fiscal year, and an
4 estimate for the planned carryover of funds into the
5 subsequent fiscal year;

6 (8) a listing of prime contractors and major
7 subcontractors; and

8 (9) narrative descriptions of risks to cost,
9 schedule, or performance that could result in a pro-
10 gram breach if not successfully mitigated.

11 (c) The Under Secretary for Management shall sub-
12 mit each approved Acquisition Decision Memorandum for
13 programs described in this section to the Committees on
14 Appropriations of the House of Representatives and the
15 Senate not later than five business days after the date of
16 approval of such memorandum by the Under Secretary for
17 Management or the designee of the Under Secretary for
18 Management.

19 SEC. 106. (a) None of the funds appropriated or oth-
20 erwise made available to the Department of Homeland Se-
21 curity by this Act or any other Act, including prior Acts
22 and laws other than appropriations Acts, may be obligated
23 for any new pilot or demonstration unless the component
24 or office carrying out such pilot or demonstration has doc-
25 umented the information described in subsection (c).

1 (b) Prior to the obligation of any such funds made
2 available for “Operations and Support” for a new pilot
3 or demonstration, the Under Secretary for Management
4 shall provide a report to the Committees on Appropria-
5 tions of the House of Representatives and the Senate on
6 the information described in subsection (c).

7 (c) The information required under subsections (a)
8 and (b) for a pilot or demonstration shall include the fol-
9 lowing—

10 (1) documented objectives that are well-defined
11 and measurable;

12 (2) an assessment methodology that details—

13 (A) the type and source of assessment
14 data;

15 (B) the methods for, and frequency of, col-
16 lecting such data; and

17 (C) how such data will be analyzed; and

18 (3) an implementation plan, including mile-
19 stones, cost estimates, and implementation sched-
20 ules, including a projected end date.

21 (d) Not later than 90 days after the date of comple-
22 tion of a pilot or demonstration described in subsection
23 (e), the Under Secretary for Management shall provide a
24 report to the Committees on Appropriations of the House
25 of Representatives and the Senate detailing lessons

1 learned, actual costs, any planned expansion or continu-
2 ation of the pilot or demonstration, and any planned tran-
3 sition of such pilot or demonstration into an enduring pro-
4 gram or operation.

5 (e) For the purposes of this section, a pilot or dem-
6 onstration program is a study, demonstration, experi-
7 mental program, or trial that—

8 (1) is a small-scale, short-term experiment con-
9 ducted in order to evaluate feasibility, duration,
10 costs, or adverse events, and improve upon the de-
11 sign of an effort prior to implementation of a larger
12 scale effort; and

13 (2) uses more than 10 full-time equivalents or
14 obligates, or proposes to obligate, \$5,000,000 or
15 more, but does not include congressionally directed
16 programs or enhancements and does not include pro-
17 grams that were in operation as of the date of the
18 enactment of this Act.

19 (f) For the purposes of this section, a pilot or dem-
20 onstration does not include any testing, evaluation, or ini-
21 tial deployment phase executed under a procurement con-
22 tract for the acquisition of information technology services
23 or systems, or any pilot or demonstration carried out by
24 a non-Federal recipient under any financial assistance
25 agreement funded by the Department.

1 SEC. 107. (a) None of the funds appropriated or oth-
2 erwise made available by this Act may be used by the Of-
3 fice of Intelligence and Analysis of the Department of
4 Homeland Security to conduct a covered activity (as de-
5 fined by section 6303 of the Intelligence Authorization Act
6 for Fiscal Year 2025 (division F of Public Law 118–159)).

7 (b) Nothing in this section shall be construed as lim-
8 iting or superseding the authority of any official within
9 the Department of Homeland Security to conduct legal,
10 privacy, civil rights, or civil liberties oversight of the intel-
11 ligence activities of the Office of Intelligence and Analysis.

12 (c) Nothing in this section shall be construed to pro-
13 hibit, or to limit the authority of, personnel of the Office
14 of Intelligence and Analysis of the Department of Home-
15 land Security from sharing intelligence information with,
16 or receiving information from—

17 (1) foreign, State, local, tribal, or territorial
18 governments (or any agency or subdivision thereof);

19 (2) the private sector; or

20 (3) other elements of the Federal Government,
21 including the components of the Department of
22 Homeland Security.

23 SEC. 108. (a) The Inspector General shall report to
24 the Committees on Appropriations of the House of Rep-
25 resentatives and the Senate on a quarterly basis on over-

1 sight of the funding provided to the Department in Public
2 Law 119–21.

3 (b) The quarterly report required in subsection (a)
4 shall include—

5 (1) a review of the spend plans for every pro-
6 gram, project, or activity funded by the Department
7 under Public Law 119–21, including the current sta-
8 tus of obligated funds compared to spend plan pro-
9 jections; and

10 (2) a summary of the audits being conducted on
11 the Department’s contracting, procurement, and ac-
12 quisition activities resulting from Public Law 119–
13 21.

14 (c) Beginning one year after the date of enactment
15 of this Act, and annually thereafter, the Inspector General
16 shall submit a comprehensive report to the Committees on
17 Appropriations of the House of Representatives and the
18 Senate on the audits, inspections, and evaluations con-
19 ducted on funds provided and activities undertaken in
20 Public Law 119–21 and shall also provide recommenda-
21 tions in such report on ways to improve effectiveness and
22 efficiency and prevent waste, fraud, and abuse of such pro-
23 grams and funds.

24 SEC. 109. (a) For an additional amount for “Office
25 of the Secretary and Executive Management—Operations

1 and Support—Office of the Secretary”, \$20,000,000, for
2 the procurement, deployment, and operations of body-
3 worn cameras for agents and officers performing enforce-
4 ment activities under 8 U.S.C. 1101 et seq.

5 (b) Within 30 days of the date of enactment of this
6 Act, the Secretary shall provide the Committees on Appro-
7 priations of the House of Representatives and the Senate
8 a spend plan for the execution of funding provided in sub-
9 section (a).

1 TITLE II
2 SECURITY, ENFORCEMENT, AND
3 INVESTIGATIONS
4 TRANSPORTATION SECURITY ADMINISTRATION
5 OPERATIONS AND SUPPORT

6 For necessary expenses of the Transportation Secu-
7 rity Administration for operations and support,
8 \$10,635,434,000, of which \$300,000,000 shall remain
9 available until September 30, 2027: *Provided*, That not
10 to exceed \$7,650 shall be for official reception and rep-
11 resentation expenses: *Provided further*, That security serv-
12 ice fees authorized under section 44940 of title 49, United
13 States Code, shall be credited to this appropriation as off-
14 setting collections and shall be available only for aviation
15 security: *Provided further*, That the sum appropriated
16 under this heading from the general fund shall be reduced
17 on a dollar-for-dollar basis as such offsetting collections
18 are received during fiscal year 2026 so as to result in a
19 final fiscal year appropriation from the general fund esti-
20 mated at not more than \$7,605,434,000.

21 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

22 For necessary expenses of the Transportation Secu-
23 rity Administration for procurement, construction, and
24 improvements, \$330,230,000, to remain available until
25 September 30, 2028.

1 RESEARCH AND DEVELOPMENT

2 For necessary expenses of the Transportation Secu-
3 rity Administration for research and development,
4 \$24,000,000, to remain available until September 30,
5 2027.

6 COAST GUARD

7 OPERATIONS AND SUPPORT

8 For necessary expenses of the Coast Guard for oper-
9 ations and support including the Coast Guard Reserve;
10 purchase or lease of not to exceed 30 passenger motor ve-
11 hicles, which shall be for replacement only; purchase or
12 lease of small boats for contingent and emergent require-
13 ments (at a unit cost of not more than \$700,000) and
14 repairs and service-life replacements, not to exceed a total
15 of \$31,000,000; purchase, lease, or improvements of boats
16 necessary for overseas deployments and activities; pay-
17 ments pursuant to section 156 of Public Law 97-377 (42
18 U.S.C. 402 note; 96 Stat. 1920); and recreation and wel-
19 fare; \$11,272,401,000, of which \$530,000,000 shall be for
20 defense-related activities; of which \$24,500,000 shall be
21 derived from the Oil Spill Liability Trust Fund to carry
22 out the purposes of section 1012(a)(5) of the Oil Pollution
23 Act of 1990 (33 U.S.C. 2712(a)(5)); of which
24 \$20,000,000 shall remain available until September 30,
25 2028; of which \$25,335,000 shall remain available until

1 September 30, 2030, for environmental compliance and
2 restoration; and of which \$400,000,000 shall remain avail-
3 able until September 30, 2027, which shall only be avail-
4 able for depot level maintenance: *Provided*, That not to
5 exceed \$23,000 shall be for official reception and represen-
6 tation expenses.

7 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

8 For necessary expenses of the Coast Guard for pro-
9 curement, construction, and improvements, including aids
10 to navigation, shore facilities (including facilities at De-
11 partment of Defense installations used by the Coast
12 Guard), and vessels and aircraft, including equipment re-
13 lated thereto, \$991,872,000, to remain available until Sep-
14 tember 30, 2030; of which \$20,000,000 shall be derived
15 from the Oil Spill Liability Trust Fund to carry out the
16 purposes of section 1012(a)(5) of the Oil Pollution Act
17 of 1990 (33 U.S.C. 2712(a)(5)).

18 RESEARCH AND DEVELOPMENT

19 For necessary expenses of the Coast Guard for re-
20 search and development; and for maintenance, rehabilita-
21 tion, lease, and operation of facilities and equipment;
22 \$6,763,000, to remain available until September 30, 2028,
23 of which \$500,000 shall be derived from the Oil Spill Li-
24 ability Trust Fund to carry out the purposes of section
25 1012(a)(5) of the Oil Pollution Act of 1990 (33 U.S.C.

1 2712(a)(5): *Provided*, That there may be credited to and
2 used for the purposes of this appropriation funds received
3 from State and local governments, other public authori-
4 ties, private sources, and foreign countries for expenses
5 incurred for research, development, testing, and evalua-
6 tion.

7
8 RETIRED PAY

8 For retired pay, including the payment of obligations
9 otherwise chargeable to lapsed appropriations for this pur-
10 pose, payments under the Retired Serviceman's Family
11 Protection and Survivor Benefits Plans, payment for ca-
12 reer status bonuses, payment of continuation pay under
13 section 356 of title 37, United States Code, concurrent
14 receipts, combat-related special compensation, and pay-
15 ments for medical care of retired personnel and their de-
16 pendants under chapter 55 of title 10, United States Code,
17 \$1,249,000,000, to remain available until expended.

18 UNITED STATES SECRET SERVICE

19 OPERATIONS AND SUPPORT

20 For necessary expenses of the United States Secret
21 Service for operations and support, including purchase of
22 not to exceed 652 vehicles for police-type use; hire of pas-
23 senger motor vehicles; purchase of motorcycles made in
24 the United States; hire of aircraft; rental of buildings in
25 the District of Columbia; fencing, lighting, guard booths,

1 and other facilities on private or other property not in
2 Government ownership or control, as may be necessary to
3 perform protective functions; conduct of and participation
4 in firearms matches; presentation of awards; conduct of
5 behavioral research in support of protective intelligence
6 and operations; payment in advance for commercial ac-
7 commodations as may be necessary to perform protective
8 functions; and payment, without regard to section 5702
9 of title 5, United States Code, of subsistence expenses of
10 employees who are on protective missions, whether at or
11 away from their duty stations; \$3,128,304,000, of which
12 \$96,299,000 shall remain available until September 30,
13 2027, and of which \$20,000,000 shall remain available
14 until September 30, 2028; and of which \$6,000,000 shall
15 be for a grant for activities related to investigations of
16 missing and exploited children; and of which up to
17 \$33,000,000 may be for calendar year 2025 premium pay
18 in excess of the annual equivalent of the limitation on the
19 rate of pay contained in section 5547(a) of title 5, United
20 States Code, pursuant to section 2 of the Overtime Pay
21 for Protective Services Act of 2016 (5 U.S.C. 5547 note),
22 as last amended by Public Law 118–38: *Provided*, That
23 not to exceed \$19,125 shall be for official reception and
24 representation expenses: *Provided further*, That not to ex-
25 ceed \$100,000 shall be to provide technical assistance and

1 equipment to foreign law enforcement organizations in
2 criminal investigations within the jurisdiction of the
3 United States Secret Service.

4 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

5 For necessary expenses of the United States Secret
6 Service for procurement, construction, and improvements,
7 \$118,517,000, of which \$96,167,000 shall remain avail-
8 able until September 30, 2028, and of which \$22,350,000
9 shall remain available until September 30, 2030.

10 RESEARCH AND DEVELOPMENT

11 For necessary expenses of the United States Secret
12 Service for research and development, \$3,250,000, to re-
13 main available until September 30, 2027.

14 ADMINISTRATIVE PROVISIONS

15 SEC. 201. Section 201 of the Department of Home-
16 land Security Appropriations Act, 2018 (division F of
17 Public Law 115–141), related to overtime compensation
18 limitations, shall apply with respect to funds made avail-
19 able in this Act in the same manner as such section ap-
20 plied to funds made available in that Act, except that “fis-
21 cal year 2026” shall be substituted for “fiscal year 2018”.

22 SEC. 202. (a) Notwithstanding any other provision
23 of law, none of the funds provided in this or any other
24 Act shall be used to approve a waiver of the navigation
25 and vessel-inspection laws pursuant to section 501(b) of

1 title 46, United States Code, for the transportation of
2 crude oil distributed from and to the Strategic Petroleum
3 Reserve until the Secretary of Homeland Security, after
4 consultation with the Secretaries of the Departments of
5 Energy and Transportation and representatives from the
6 United States flag maritime industry, takes adequate
7 measures to ensure the use of United States flag vessels.

8 (b) The Secretary shall notify the Committees on Ap-
9 propriations of the House of Representatives and the Sen-
10 ate, the Committee on Transportation and Infrastructure
11 of the House of Representatives, and the Committee on
12 Commerce, Science, and Transportation of the Senate
13 within two business days of any request for waivers of
14 navigation and vessel-inspection laws pursuant to section
15 501(b) of title 46, United States Code, with respect to
16 such transportation, and the disposition of such requests.

17 SEC. 203. (a) Beginning on the date of enactment
18 of this Act, the Secretary of Homeland Security shall
19 not—

20 (1) establish, collect, or otherwise impose any
21 new border crossing fee on individuals crossing the
22 Southern border or the Northern border at a land
23 port of entry; or

24 (2) conduct any study relating to the imposition
25 of a border crossing fee.

1 (b) In this section, the term “border crossing fee”
2 means a fee that every pedestrian, cyclist, and driver and
3 passenger of a private motor vehicle is required to pay
4 for the privilege of crossing the Southern border or the
5 Northern border at a land port of entry.

6 SEC. 204. (a) Not later than 90 days after the date
7 of enactment of this Act, the Commissioner of U.S. Cus-
8 toms and Border Protection shall submit an expenditure
9 plan for any amounts made available for “U.S. Customs
10 and Border Protection—Procurement, Construction, and
11 Improvements” in prior Acts to the Committees on Appro-
12 priations of the House of Representatives and the Senate.

13 (b) No such amounts provided in prior Acts may be
14 obligated prior to the submission of such plan.

15 SEC. 205. (a) Funds made available in this Act may
16 be used to alter operations within the National Targeting
17 Center of U.S. Customs and Border Protection.

18 (b) None of the funds provided by this Act, provided
19 by previous appropriations Acts that remain available for
20 obligation or expenditure in fiscal year 2026, or provided
21 from any accounts in the Treasury of the United States
22 derived by the collection of fees available to the compo-
23 nents funded by this Act, may be used to reduce antici-
24 pated or planned vetting operations at existing locations

1 unless specifically authorized by a statute enacted after
2 the date of enactment of this Act.

3 SEC. 206. None of the funds made available for Bor-
4 der Security Assets and Infrastructure under the heading
5 “U.S. Customs and Border Protection—Procurement,
6 Construction, and Improvements” in prior appropriations
7 Acts shall be used for the procurement or deployment of
8 surveillance systems that are not autonomous, as such
9 term is defined in section 90004 of Public Law 119–21.

10 SEC. 207. The Secretary shall ensure that the No-
11 vember 30, 2021, policy statement from U.S. Customs and
12 Border Protection titled “Policy Statement and Required
13 Actions Regarding Pregnant, Postpartum, Nursing Indi-
14 viduals, and Infants in Custody,” or substantively similar
15 standards of treatment developed in consultation with ma-
16 ternal and pediatric health providers and experts, are in
17 effect and are fully implemented to safeguard the health,
18 safety, and rights of pregnant women in U.S. Customs
19 and Border Protection custody.

20 SEC. 208. None of the funds appropriated or other-
21 wise made available to the Department of Homeland Secu-
22 rity by this Act or any other Act, including prior Acts and
23 laws other than appropriations Acts, may be used to con-
24 tinue a delegation of law enforcement authority authorized
25 under section 287(g) of the Immigration and Nationality

1 Act (8 U.S.C. 1357(g)) if the Department of Homeland
2 Security Inspector General determines that the terms of
3 the agreement governing the delegation of authority have
4 been materially violated.

5 SEC. 209. (a) None of the funds appropriated or oth-
6 erwise made available to the Department of Homeland Se-
7 curity by this Act or any other Act, including prior Acts
8 and laws other than appropriations Acts, may be used to
9 continue any contract for the provision of detention serv-
10 ices if the two most recent overall performance evaluations
11 received by the contracted facility are less than “ade-
12 quate” or the equivalent median score in any subsequent
13 performance evaluation system.

14 (b) The performance evaluations referenced in sub-
15 section (a) shall be conducted by the U.S. Immigration
16 and Customs Enforcement Office of Professional Respon-
17 sibility.

18 SEC. 210. (a) The reports required to be submitted
19 under section 216 of the Department of Homeland Secu-
20 rity Appropriations Act, 2021 (division F of Public Law
21 116–260) shall continue to be submitted semimonthly and
22 each matter required to be included in such reports by
23 such section 216 shall apply in the same manner and to
24 the same extent during the period described in such sec-
25 tion 216.

1 (b) The reports described in subsection (a) shall
2 apply in the same manner and to the same extent to the
3 funds provided to the Department of Homeland Security
4 by Public Law 119–21.

5 SEC. 211. The terms and conditions of sections 216
6 and 217 of the Department of Homeland Security Appro-
7 priations Act, 2020 (division D of Public Law 116–93)
8 shall apply to this Act and to Public Law 119–21.

9 SEC. 212. (a) Not later than 30 days after the date
10 of enactment of this Act, the Director of U.S. Immigration
11 and Customs Enforcement shall provide a briefing and
12 submit an initial, written obligation plan for funding pro-
13 vided under the heading “U.S. Immigration and Customs
14 Enforcement” in this or any other Act, including prior
15 Acts, to the Committees on Appropriations of the House
16 of Representatives and the Senate, which shall—

17 (1) be delineated by month, level II program,
18 project, and activity, and pay and non-pay require-
19 ments;

20 (2) incorporate and delineate all funding
21 sources available to U.S. Immigration and Customs
22 Enforcement, to include unobligated carryover bal-
23 ances and fees; and

1 (3) contain data-driven assumptions for major
2 contract costs, projected personnel levels, and oper-
3 ational and policy considerations.

4 (b) The Director of U.S. Immigration and Customs
5 Enforcement shall provide monthly briefings and written
6 updates to the plan required in subsection (a), which shall
7 include, at a minimum, the following information as of the
8 conclusion of the preceding month—

9 (1) actual obligations and expenditures, includ-
10 ing prior year;

11 (2) carryover from prior year unobligated bal-
12 ances;

13 (3) resource projections for the remainder of
14 the fiscal year;

15 (4) payroll projections for the remainder of the
16 fiscal year, based on forecasted gains and losses;

17 (5) identification of any contracts with a period
18 of performance extending beyond the current fiscal
19 year;

20 (6) obligations and expenditures for specific do-
21 mestic and international investigative mission areas,
22 including countering fentanyl and child exploitation;

23 (7) the rate of operations for the Custody Oper-
24 ations, Alternatives to Detention, and Transpor-
25 tation and Removal Operations programs, projects,

1 and activities, which shall include a projection of the
2 exhaustion of funds based on current resources and
3 operational levels; and

4 (8) the initial obligation plan as described in
5 subsection (a), displayed unchanged for the purposes
6 of comparison.

7 (c) The monthly updates required by subsection (b)
8 shall be submitted no later than 15 days after the begin-
9 ning of the month following the submission of the initial
10 obligation plan as described in subsection (a).

11 SEC. 213. (a) Not later than 90 days after the date
12 of enactment of this Act, the Director of U.S. Immigration
13 and Customs Enforcement shall submit to the Committees
14 on Appropriations of the House of Representatives and the
15 Senate a written execution plan for the funding provided
16 by Public Law 119–21 for detention facilities, to include
17 the following elements:

18 (1) the location, number of beds, and estimated
19 cost per bed of each detention facility utilized by or
20 on behalf of U.S. Immigration and Customs En-
21 forcement in the preceding quarter;

22 (2) the location, number of beds, and estimated
23 cost per bed of each detention facility projected to
24 be utilized by or on behalf of U.S. Immigration and
25 Customs Enforcement in the subsequent quarter;

1 (3) the total number of beds projected to be uti-
2 lized by or on behalf of U.S. Immigration and Cus-
3 toms Enforcement through the end of the fiscal
4 year;

5 (4) any associated increase or decrease in trans-
6 portation and removal operations cost estimates as-
7 sociated with paragraphs (1), (2), and (3) of this
8 section, to include removal flights; and

9 (5) a general overview of the desired geographic
10 end-state for detention facilities, any new operational
11 models or strategies related to detention capacity
12 that will be utilized, and a comparison of current de-
13 tention capacity against projected end-state capacity.

14 (b)(1) Subsequent to the submission of the written
15 execution plan provided in subsection (a), the Director of
16 U.S. Immigration and Customs Enforcement shall provide
17 to the Committees on Appropriations of the House of Rep-
18 resentatives and the Senate a briefing and written update
19 to such execution plan not later than 30 days following
20 the end of each fiscal quarter; and

21 (2) each briefing and written update described
22 in paragraph (1) shall include a review of the execu-
23 tion of funds for the most recently completed quar-
24 ter, a comparison of the actual execution of funds in
25 relation to the planned execution of funds, and any

1 remedial actions taken in the case of a failure to
2 execute funding in accordance with the initial execu-
3 tion plan as described in subsection (a); and

4 (c) The initial execution plan described in subsection
5 (a) shall be displayed unchanged for purposes of compari-
6 son in the briefings and written updates described in sub-
7 section (b).

8 SEC. 214. (a) Members of the United States House
9 of Representatives and the United States Senate, includ-
10 ing the leadership; the heads of Federal agencies and com-
11 missions, including the Secretary, Deputy Secretary,
12 Under Secretaries, and Assistant Secretaries of the De-
13 partment of Homeland Security; the United States Attor-
14 ney General, Deputy Attorney General, Assistant Attor-
15 neys General, and the United States Attorneys; and senior
16 members of the Executive Office of the President, includ-
17 ing the Director of the Office of Management and Budget,
18 shall not be exempt from Federal passenger and baggage
19 screening.

20 (b) None of the funds made available in this or any
21 other Act, including prior Acts, or provided from any ac-
22 counts in the Treasury of the United States derived by
23 the collection of fees available to the components funded
24 by this Act may be used to carry out legislation altering

1 the applicability of the screening requirements outlined in
2 subsection (a).

3 SEC. 215. Notwithstanding section 44923 of title 49,
4 United States Code, for fiscal year 2026, any funds in
5 the Aviation Security Capital Fund established by section
6 44923(h) of title 49, United States Code, may be used
7 for the procurement and installation of explosives detec-
8 tion systems or for the issuance of other transaction agree-
9 ments for the purpose of funding projects described in sec-
10 tion 44923(a) of such title.

11 SEC. 216. Not later than 45 days after the submis-
12 sion of the President's budget proposal, the Administrator
13 of the Transportation Security Administration shall sub-
14 mit to the Committees on Appropriations and Homeland
15 Security of the House of Representatives and the Commit-
16 tees on Appropriations and Commerce, Science, and
17 Transportation of the Senate a single report that fulfills
18 the following requirements:

19 (1) a Capital Investment Plan, both constrained
20 and unconstrained, that includes a plan for contin-
21 uous and sustained capital investment in new, and
22 the replacement of aged, transportation security
23 equipment;

24 (2) the 5-year technology investment plan as re-
25 quired by section 1611 of title XVI of the Homeland

1 Security Act of 2002, as amended by section 3 of
2 the Transportation Security Acquisition Reform Act
3 (Public Law 113–245); and

4 (3) the Advanced Integrated Passenger Screen-
5 ing Technologies report as required by the Senate
6 Report accompanying the Department of Homeland
7 Security Appropriations Act, 2019 (Senate Report
8 115–283).

9 SEC. 217. Section 515(b) of Public Law 108–334 (49
10 U.S.C. 44945 note) is amended by striking “report” each
11 place it appears (including in the subsection heading) and
12 inserting “briefing” and by striking “transmit to” and in-
13 serting “provide”.

14 SEC. 218. (a) None of the funds made available by
15 this Act under the heading “Coast Guard—Operations
16 and Support” shall be for expenses incurred for rec-
17 reational vessels under section 12114 of title 46, United
18 States Code, except to the extent fees are collected from
19 owners of yachts and credited to the appropriation made
20 available by this Act under the heading “Coast Guard—
21 Operations and Support”.

22 (b) To the extent such fees are insufficient to pay
23 expenses of recreational vessel documentation under such
24 section 12114, and there is a backlog of recreational vessel
25 applications, personnel performing non-recreational vessel

1 documentation functions under subchapter II of chapter
2 121 of title 46, United States Code, may perform docu-
3 mentation under section 12114.

4 SEC. 219. Notwithstanding any other provision of
5 law, the Commandant of the Coast Guard shall submit
6 to the Committees on Appropriations of the House of Rep-
7 resentatives and the Senate a future-years capital invest-
8 ment plan as described in the second proviso under the
9 heading “Coast Guard—Acquisition, Construction, and
10 Improvements” in the Department of Homeland Security
11 Appropriations Act, 2015 (Public Law 114–4), which shall
12 be subject to the requirements in the third and fourth pro-
13 visos under such heading.

14 SEC. 220. None of the funds in this Act shall be used
15 to reduce the Coast Guard’s legacy Operations Systems
16 Center mission or its government-employed or contract
17 staff levels.

18 SEC. 221. None of the funds appropriated by this Act
19 may be used to conduct, or to implement the results of,
20 a competition under Office of Management and Budget
21 Circular A–76 for activities performed with respect to the
22 Coast Guard National Vessel Documentation Center.

23 SEC. 222. Funds made available in this Act may be
24 used to alter operations within the Civil Engineering Pro-
25 gram of the Coast Guard nationwide, including civil engi-

1 neering units, facilities design and construction centers,
2 maintenance and logistics commands, and the Coast
3 Guard Academy, except that none of the funds provided
4 in this Act may be used to reduce operations within any
5 civil engineering unit unless specifically authorized by a
6 statute enacted after the date of enactment of this Act.

7 SEC. 223. Amounts deposited into the Coast Guard
8 Housing Fund in fiscal year 2026 shall be available until
9 expended to carry out the purposes of section 2946 of title
10 14, United States Code, and shall be in addition to funds
11 otherwise available for such purposes.

12 SEC. 224. (a) For an additional amount for “Coast
13 Guard—Procurement, Construction, and Improvements”,
14 \$98,000,000, to remain available until September 30,
15 2030, for the procurement and acquisition of MQ–9 air-
16 craft and associated base stations, equipment related to
17 such aircraft and associated base stations, and program
18 management for such aircraft and base stations.

19 (b) None of the funds made available for the Depart-
20 ment of Homeland Security in this or any prior Act may
21 be used to procure or acquire long-range unmanned air-
22 craft with kinetic capabilities or to equip any long-range
23 unmanned aircraft with kinetic capabilities.

24 SEC. 225. None of the funds appropriated or other-
25 wise made available to the Department of Homeland Secu-

1 rity by this Act or any other Act, including prior Acts and
2 laws other than appropriations Acts, may be available for
3 implementation of Force Design 2028 until the Coast
4 Guard provides the Committees on Appropriations of the
5 House of Representatives and the Senate detailed brief-
6 ings on the initiatives of organization, people, technology,
7 and contracting and acquisitions.

8 SEC. 226. The United States Secret Service is au-
9 thorized to obligate funds in anticipation of reimburse-
10 ments from executive agencies, as defined in section 105
11 of title 5, United States Code, for personnel receiving
12 training sponsored by the James J. Rowley Training Cen-
13 ter, except that total obligations at the end of the fiscal
14 year shall not exceed total budgetary resources available
15 under the heading “United States Secret Service—Oper-
16 ations and Support” at the end of the fiscal year.

17 SEC. 227. (a) None of the funds made available to
18 the United States Secret Service by this Act or by previous
19 appropriations Acts may be made available for the protec-
20 tion of the head of a Federal agency other than the Sec-
21 retary of Homeland Security.

22 (b) The Director of the United States Secret Service
23 may enter into agreements to provide such protection on
24 a fully reimbursable basis.

1 SEC. 228. For purposes of section 503(a)(3) of this
2 Act, up to \$15,000,000 may be reprogrammed within
3 “United States Secret Service—Operations and Support”.

4 SEC. 229. Funding made available in this Act for
5 “United States Secret Service—Operations and Support”
6 is available for travel of United States Secret Service em-
7 ployees on protective missions without regard to the limi-
8 tations on such expenditures in this or any other Act if
9 the Director of the United States Secret Service or a des-
10 ignee notifies the Committees on Appropriations of the
11 House of Representatives and the Senate 10 or more days
12 in advance, or as early as practicable, prior to such ex-
13 penditures.

14 SEC. 230. Of the amounts made available by this Act
15 under the heading “United States Secret Service—Oper-
16 ations and Support”, \$2,000,000, to remain available
17 until expended, shall be distributed as a grant or coopera-
18 tive agreement for existing National Computer Forensics
19 Institute facilities currently used by the United States Se-
20 cret Service to carry out activities under section 383 of
21 title 6, United States Code.

22 SEC. 231. (a) Section 118 of the Treasury and Gen-
23 eral Government Appropriations Act, 2001 (5 U.S.C.
24 5547 note) is amended, in the first sentence, by inserting
25 “(or, for 2024, to the extent that such aggregate amount

1 would exceed the per annum rate of salary payable under
2 section 104 of title 3, United States Code)” before the
3 period at the end.

4 (b) Subsection (a) shall take effect as if enacted on
5 December 31, 2023.

6 (c) Not later than 180 days after the date of enact-
7 ment of this Act, and annually thereafter through 2028,
8 the Director shall submit to the Committee on Appropria-
9 tions of the House of Representatives and the Senate; the
10 Committee on Homeland Security, the Committee on
11 Oversight and Accountability, and the Committee on the
12 Judiciary of the House of Representatives; and the Com-
13 mittee on Homeland Security and Governmental Affairs,
14 and the Committee on the Judiciary of the Senate of Con-
15 gress a report describing the steps that the United States
16 Secret Service is taking to address the increased protective
17 service demands placed upon United States Secret Service
18 personnel.

19 (d) Each report required under subparagraph (c)
20 shall include the following:

21 (1) An analysis of the current (as of the date
22 on which the report is submitted) operational de-
23 mands and staffing levels with respect to the United
24 States Secret Service.

1 (2) Recommended strategies for reducing over-
2 time requirements for United States Secret Service
3 personnel, including—

4 (A) the appointment of additional per-
5 sonnel;

6 (B) solutions such that sufficient resources
7 are available throughout each year without the
8 need for exceptions to, or waivers of, premium
9 pay limitations;

10 (C) the redistribution of workload among
11 United States Secret Service personnel; and

12 (D) other improvements in operational effi-
13 ciency with respect to the United States Secret
14 Service.

15 (e) Within the reports required under paragraphs (3)
16 and (4) of section 2(c) of the Overtime Pay for Protective
17 Services Act of 2023 (Public Law 118–38; 138 Stat. 13)
18 that are submitted after the date of enactment of this Act,
19 the Director shall include information about—

20 (1) the average number of overtime hours and
21 range of number of overtime hours completed by
22 United States Secret Service personnel receiving pre-
23 mium pay above the pay limitation in subsection (a)
24 of section 5547 of title 5, United States Code; and

1 (2) the average number of overtime hours and
2 range of number of overtime hours completed by
3 United States Secret Service personnel who are not
4 fully compensated for their overtime because their
5 premium pay would be above the pay limitation in
6 section 2 of the Overtime Pay Protection Act of
7 2016 (5 U.S.C. 5547 note).

8 (f) The matter preceding the first proviso under the
9 heading “United States Secret Service—Operations and
10 Support” in division C of Public Law 118–47 shall be ap-
11 plied to funds appropriated by this Act by substituting
12 “\$40,000,000” for “\$24,000,000” and substituting
13 “2024” for “2023”.

14 SEC. 232. Section 211 of the Department of Home-
15 land Security Appropriations Act, 2021 (division F of
16 Public Law 116–260), prohibiting the use of funds for the
17 construction of fencing in certain areas, shall apply with
18 respect to funds made available in this Act and in Public
19 Law 119–21, in the same manner as such section applied
20 to funds made available in that Act.

8 be for official reception and representation expenses.

8 graph in accordance with subsection (c)(1) of such

10 (2) \$584,250,000 for the Urban Area Security
11 Initiative under section 2003 of the Homeland Secu-
12 rity Act of 2002 (6 U.S.C. 604).

13 (3) \$300,000,000 for the Nonprofit Security
14 Grant Program under section 2009 of the Homeland
15 Security Act of 2002 (6 U.S.C. 609a), of which
16 \$150,000,000 is for eligible recipients located in
17 high-risk urban areas that receive funding under
18 section 2003 of such Act and \$150,000,000 is for el-
19 igible recipients that are located outside such areas:
20 *Provided*, That eligible recipients are those described
21 in section 2009(b) of such Act (6 U.S.C. 609a(b))
22 or are an otherwise eligible recipient at risk of a ter-
23 rorist or other extremist attack.

24 (4) \$99,750,000 for Public Transportation Se-

16 \$342,000,000 shall be for Staffing for Adequate
17 Fire and Emergency Response Grants under sec-
18 tions 33 and 34 respectively of the Federal Fire Pre-
19 vention and Control Act of 1974 (15 U.S.C. 2229
20 and 2229a).

21 (7) \$337,250,000 for emergency management
22 performance grants under the National Flood Insur-
23 ance Act of 1968 (42 U.S.C. 4001 et seq.), the Rob-
24 ert T. Stafford Disaster Relief and Emergency As-
25 sistance Act (42 U.S.C. 5121), the Earthquake Haz-

1 ards Reduction Act of 1977 (42 U.S.C. 7701), sec-
2 tion 762 of title 6, United States Code, and Reorga-
3 nization Plan No. 3 of 1978 (5 U.S.C. App.).

4 (8) \$297,113,000 for necessary expenses for
5 Flood Hazard Mapping and Risk Analysis, in addi-
6 tion to and to supplement any other sums appro-
7 priated under the National Flood Insurance Fund,
8 and such additional sums as may be provided by
9 States or other political subdivisions for cost-shared
10 mapping activities under section 1360(f)(2) of the
11 National Flood Insurance Act of 1968 (42 U.S.C.
12 4101(f)(2)), to remain available until expended.

13 (9) \$11,400,000 for Regional Catastrophic Pre-
14 paredness Grants.

15 (10) \$11,400,000 for Rehabilitation of High
16 Hazard Potential Dams under section 8A of the Na-
17 tional Dam Safety Program Act (33 U.S.C. 467f-2).

18 (11) \$123,500,000 for the emergency food and
19 shelter program under title III of the McKinney-
20 Vento Homeless Assistance Act (42 U.S.C. 11331),
21 to remain available until September 30, 2027: *Pro-*
22 *vided*, That not to exceed 3.5 percent shall be for
23 total administrative costs.

24 (12) \$48,000,000 for the Next Generation
25 Warning System.

1 (13) \$272,671,513 for Community Project
2 Funding and Congressionally Directed Spending
3 grants, which shall be for the purposes, and the
4 amounts, specified in the table entitled “Homeland
5 Security—Community Project Funding/Congression-
6 ally Directed Spending” under the “Disclosure of
7 Earmarks and Congressionally Directed Spending
8 Items” heading in the explanatory statement de-
9 scribed in section 553 of this Act, of which—

10 (A) \$82,957,854, in addition to amounts
11 otherwise made available for such purpose, is
12 for emergency operations center grants under
13 section 614 of the Robert T. Stafford Disaster
14 Relief and Emergency Assistance Act (42
15 U.S.C. 5196c); and

16 (B) \$189,713,659, in addition to amounts
17 otherwise made available for such purpose, is
18 for pre-disaster mitigation grants under section
19 203 of the Robert T. Stafford Disaster Relief
20 and Emergency Assistance Act (42 U.S.C.

1 (14) \$478,414,000 to sustain current oper-
2 ations for training, exercises, technical assistance,
3 and other programs, of which—

4 (A) \$85,711,000 is for the Center for Do-
5 mestic Preparedness;

6 (B) \$17,100,000 is for the Center for
7 Homeland Defense and Security;

8 (C) \$33,366,000 is for the Emergency
9 Management Institute;

10 (D) \$72,140,000 is for the United States
11 Fire Administration;

12 (E) \$95,950,000 is for the National Do-
13 mestic Preparedness Consortium;

14 (F) \$15,200,000 is for Continuing Train-
15 ing Grants;

16 (G) \$21,266,000 is for the National Exer-
17 cise Program;

18 (H) \$83,657,000 is for the Biological Sup-
19 port Program;

20 (I) \$34,465,000 is for the Securing the
21 Cities Program; and

22 (J) \$19,559,000 is for Countering Weap-
23 ons of Mass Destruction Training, Exercises,
24 and Readiness.

1 DISASTER RELIEF FUND

2 For necessary expenses in carrying out the Robert
3 T. Stafford Disaster Relief and Emergency Assistance Act
4 (42 U.S.C. 5121 et seq.), \$26,367,000,000, to remain
5 available until expended: *Provided*, That such amount
6 shall be for major disasters declared pursuant to the Rob-
7 ert T. Stafford Disaster Relief and Emergency Assistance
8 Act (42 U.S.C. 5121 et seq.) and is designated by the
9 Congress as being for disaster relief pursuant to a concur-
10 rent resolution on the budget.

11 NATIONAL FLOOD INSURANCE FUND

12 For activities under the National Flood Insurance
13 Act of 1968 (42 U.S.C. 4001 et seq.), the Flood Disaster
14 Protection Act of 1973 (42 U.S.C. 4001 et seq.), the
15 Biggert-Waters Flood Insurance Reform Act of 2012
16 (Public Law 112–141, 126 Stat. 916), and the Home-
17 owner Flood Insurance Affordability Act of 2014 (Public
18 Law 113–89; 128 Stat. 1020), \$226,000,000, to remain
19 available until September 30, 2027, which shall be derived
20 from offsetting amounts collected under section 1308(d)
21 of the National Flood Insurance Act of 1968 (42 U.S.C.
22 4015(d)); of which \$16,302,000 shall be available for mis-
23 sion support associated with flood management; and of
24 which \$209,698,000 shall be available for flood plain man-
25 agement and flood mapping: *Provided*, That any addi-

1 tional fees collected pursuant to section 1308(d) of the
2 National Flood Insurance Act of 1968 (42 U.S.C.
3 4015(d)) shall be credited as offsetting collections to this
4 account, to be available for flood plain management and
5 flood mapping: *Provided further*, That in fiscal year 2026,
6 no funds shall be available from the National Flood Insur-
7 ance Fund under section 1310 of the National Flood In-
8 surance Act of 1968 (42 U.S.C. 4017) in excess of—

9 (1) \$230,669,000 for operating expenses and
10 salaries and expenses associated with flood insurance
11 operations;

12 (2) \$1,505,000,000 for commissions and taxes
13 of agents;

14 (3) such sums as are necessary for interest on
15 Treasury borrowings; and

16 (4) \$175,000,000, which shall remain available
17 until expended, for flood mitigation actions and for
18 flood mitigation assistance under section 1366 of the
19 National Flood Insurance Act of 1968 (42 U.S.C.
20 4104e), notwithstanding sections 1366(e) and
21 1310(a)(7) of such Act (42 U.S.C. 4104e(e), 4017):

22 *Provided further*, That the amounts collected under section
23 102 of the Flood Disaster Protection Act of 1973 (42
24 U.S.C. 4012a) and section 1366(e) of the National Flood
25 Insurance Act of 1968 (42 U.S.C. 4104c(e)), shall be de-

1 posited in the National Flood Insurance Fund to supple-
2 ment other amounts specified as available for section 1366
3 of the National Flood Insurance Act of 1968, notwith-
4 standing section 102(f)(8), section 1366(e) of the National
5 Flood Insurance Act of 1968, and paragraphs (1) through
6 (3) of section 1367(b) of such Act (42 U.S.C. 4012a(f)(8),
7 4104c(e), 4104d(b)(1)–(3)): *Provided further*, That total
8 administrative costs shall not exceed 4 percent of the total
9 appropriation: *Provided further*, That up to \$4,000,000 is
10 available to carry out section 24 of the Homeowner Flood
11 Insurance Affordability Act of 2014 (42 U.S.C. 4033).

12 ADMINISTRATIVE PROVISIONS

13 (INCLUDING TRANSFERS OF FUNDS)

14 SEC. 301. Funds made available under the heading
15 “Cybersecurity and Infrastructure Security Agency—Op-
16 erations and Support” may be made available for the nec-
17 essary expenses of procuring or providing access to cyber-
18 security threat feeds for branches, agencies, independent
19 agencies, corporations, establishments, and instrumental-
20 ities of the Federal Government of the United States,
21 State, local, tribal, and territorial entities, fusion centers
22 as described in section 210A of the Homeland Security
23 Act (6 U.S.C. 124h), and Information Sharing and Anal-
24 ysis Organizations.

1 SEC. 302. (a) Notwithstanding section 2008(a)(12)
2 of the Homeland Security Act of 2002 (6 U.S.C.
3 609(a)(12)) or any other provision of law, not more than
4 5 percent of the amount of a grant made available in para-
5 graphs (1) through (5) under “Federal Emergency Man-
6 agement Agency—Federal Assistance”, may be used by
7 the recipient for expenses directly related to administra-
8 tion of the grant.

9 (b) The authority provided in subsection (a) shall also
10 apply to a state recipient for the administration of a grant
11 under such paragraph (3).

12 SEC. 303. (a) Applications for grants under the head-
13 ing “Federal Emergency Management Agency—Federal
14 Assistance”, for paragraphs (1) through (5), shall be
15 made available to eligible applicants not later than 60 days
16 after the date of enactment of this Act, eligible applicants
17 shall submit applications not later than 80 days after the
18 grant announcement, and the Administrator of the Fed-
19 eral Emergency Management Agency shall act within 65
20 days after the receipt of an application.

21 (b) Amounts appropriated by this Act for “Federal
22 Emergency Management Agency—Operations and Sup-
23 port” shall be reduced by \$100,000 for each day past the
24 60-day requirement that applications are not made avail-
25 able to eligible applicants as required in subsection (a),

1 and the amount made available under such heading and
2 specified in the “Department of Homeland Security Ap-
3 propriations Act, 2026” table in the explanatory state-
4 ment described in section 553 of this Act for Mission Sup-
5 port shall be correspondingly reduced by an equivalent
6 amount.

7 SEC. 304. (a) Under the heading “Federal Emer-
8 gency Management Agency—Federal Assistance”, for
9 grants under paragraphs (1) through (5), (9), and (10)
10 the Administrator of the Federal Emergency Management
11 Agency shall brief the Committees on Appropriations of
12 the House of Representatives and the Senate five full busi-
13 ness days in advance of announcing publicly the intention
14 of making an award.

15 (b) If any such public announcement is made before
16 five full business days have elapsed following such briefing,
17 \$1,000,000 of amounts appropriated by this Act for “Fed-
18 eral Emergency Management Agency—Operations and
19 Support” shall be rescinded, and the amount made avail-
20 able under such heading and specified in the “Department
21 of Homeland Security Appropriations Act, 2026” table in
22 the explanatory statement described in section 553 of this
23 Act for Mission Support shall be correspondingly reduced
24 by an equivalent amount.

1 SEC. 305. Under the heading “Federal Emergency
2 Management Agency—Federal Assistance”, for grants
3 under paragraphs (1) and (2), the installation of commu-
4 nications towers is not considered construction of a build-
5 ing or other physical facility.

6 SEC. 306. The reporting requirements in paragraphs
7 (1) and (2) under the heading “Federal Emergency Man-
8 agement Agency—Disaster Relief Fund” in the Depart-
9 ment of Homeland Security Appropriations Act, 2015
10 (Public Law 114–4), related to reporting on the Disaster
11 Relief Fund, shall be applied in fiscal year 2026 with re-
12 spect to budget year 2027 and current fiscal year 2026,
13 respectively—

14 (1) in paragraph (1) by substituting “fiscal
15 year 2027” for “fiscal year 2016”; and

16 (2) in paragraph (2) by inserting “business”
17 after “fifth”.

18 SEC. 307. In making grants under the heading “Fed-
19 eral Emergency Management Agency—Federal Assist-
20 ance”, for Staffing for Adequate Fire and Emergency Re-
21 sponse grants, the Administrator of the Federal Emer-
22 gency Management Agency may grant waivers from the
23 requirements in subsections (a)(1)(A), (a)(1)(B),
24 (a)(1)(E), (c)(1), (c)(2), and (c)(4) of section 34 of the

1 Federal Fire Prevention and Control Act of 1974 (15
2 U.S.C. 2229a).

3 SEC. 308. (a) The aggregate charges assessed during
4 fiscal year 2026, as authorized in title III of the Depart-
5 ments of Veterans Affairs and Housing and Urban Devel-
6 opment, and Independent Agencies Appropriations Act,
7 1999 (42 U.S.C. 5196e), shall not be less than 100 per-
8 cent of the amounts anticipated by the Department of
9 Homeland Security to be necessary for its Radiological
10 Emergency Preparedness Program for the next fiscal year.

11 (b) The methodology for assessment and collection of
12 fees shall be fair and equitable and shall reflect costs of
13 providing such services, including administrative costs of
14 collecting such fees.

15 (c) Such fees shall be deposited in a Radiological
16 Emergency Preparedness Program account as offsetting
17 collections and will become available for authorized pur-
18 poses on October 1, 2026, and remain available until ex-
19 pended.

20 SEC. 309. In making grants under the heading “Fed-
21 eral Emergency Management Agency—Federal Assist-
22 ance”, for Assistance to Firefighter Grants, the Adminis-
23 trator of the Federal Emergency Management Agency
24 may waive subsection (k) of section 33 of the Federal Fire
25 Prevention and Control Act of 1974 (15 U.S.C. 2229).

1 SEC. 310. Any unobligated balances of funds appro-
2 priated in any prior Act for activities funded by the Na-
3 tional Predisaster Mitigation Fund under section 203 of
4 the Robert T. Stafford Disaster Relief and Emergency As-
5 sistance Act (42 U.S.C. 5133), as in effect on the day
6 before the date of enactment of section 1234 of division
7 D of Public Law 115–254, shall be transferred to and
8 merged with funds set aside pursuant to subsection (i)(1)
9 of section 203 of the Robert T. Stafford Disaster Relief
10 and Emergency Assistance Act (42 U.S.C. 5133), as in
11 effect on the date of the enactment of this section.

12 SEC. 311. Any unobligated balances of funds appro-
13 priated under the heading “Federal Emergency Manage-
14 ment Agency—Flood Hazard Mapping and Risk Analysis
15 Program” in any prior Act shall be transferred to and
16 merged with funds appropriated under the heading “Fed-
17 eral Emergency Management Agency—Federal Assist-
18 ance” for necessary expenses for Flood Hazard Mapping
19 and Risk Analysis: *Provided*, That funds transferred pur-
20 suant to this section shall be in addition to and supple-
21 ment any other sums appropriated for such purposes
22 under the National Flood Insurance Fund and such addi-
23 tional sums as may be provided by States or other political
24 subdivisions for cost-shared mapping activities under sec-
25 tion 1360(f)(2) of the National Flood Insurance Act of

1 1968 (42 U.S.C. 4101(f)(2)), to remain available until ex-
2 pended.

3 SEC. 312. Each award for grants under the heading
4 “Federal Emergency Management Agency—Federal As-
5 sistance” for paragraphs (1) through (10) and (12), shall
6 have a period of performance, as defined by 2 CFR 200.1,
7 that shall be of not less than three years and not more
8 than five years.

9 SEC. 313. (a) The Administrator of the Federal
10 Emergency Management Agency shall post an interactive
11 dashboard on the public-facing website of the Federal
12 Emergency Management Agency with any request for re-
13 imbursement for a covered expense, delineated by state
14 and any amount for individual assistance or public assist-
15 ance related to emergency (42 U.S.C. 5122(1)) or major
16 disaster (42 U.S.C. 5122(2)) declarations under the Rob-
17 ert T. Stafford Disaster Relief and Emergency Assistance
18 Act (42 U.S.C. 5121 et seq.)—

19 (1) not more than 90 days after such informa-
20 tion has been received by the Federal Emergency
21 Management Agency; and

22 (2) not more than 60 days after such informa-
23 tion is under final review by the Department of
24 Homeland Security.

1 (b) The information in the interactive dashboard ref-
2 erenced in subsection (a) shall include at a minimum the
3 information listed in subparagraphs (1) through (7) under
4 the heading in the paragraph titled “Public and Individual
5 Assistance” in the explanatory statement described in sec-
6 tion 553 of this Act.

7 SEC. 314. (a) None of the funds appropriated in this
8 Act may be used to pause a training or grant funded
9 under the heading “Federal Emergency Management
10 Agency—Federal Assistance”.

11 (b) Subsection (a) shall not apply if the Secretary of
12 Homeland Security notifies the Committees on Appropria-
13 tions of the House of Representatives and the Senate not
14 more than 10 business days in advance of the pause.

15 (c) The notification required by subsection (b) shall
16 include an explanation for the pause, plans to make up
17 any missed classes resulting from the pause, and the budg-
18 etary impact of any paused training.

19 (d) The Secretary may waive the requirement in sub-
20 section (b) in the event of extraordinary circumstances
21 that imminently threaten the safety of human life or the
22 protection of property.

1 TITLE IV
2 RESEARCH, DEVELOPMENT, TRAINING, AND
3 SERVICES

4 U.S. CITIZENSHIP AND IMMIGRATION SERVICES
5 OPERATIONS AND SUPPORT

6 For necessary expenses of U.S. Citizenship and Im-
7 migration Services for operations and support, including
8 for the E-Verify Program, \$122,941,000: *Provided*, That
9 such amounts shall be in addition to any other amounts
10 made available for such purposes, and shall not be con-
11 strued to require any reduction of any fee described in
12 section 286(m) of the Immigration and Nationality Act
13 (8 U.S.C. 1356(m)): *Provided further*, That not to exceed
14 \$5,000 shall be for official reception and representation
15 expenses.

16 FEDERAL LAW ENFORCEMENT TRAINING CENTERS
17 OPERATIONS AND SUPPORT

18 For necessary expenses of the Federal Law Enforce-
19 ment Training Centers for operations and support, includ-
20 ing the purchase of not to exceed 117 vehicles for police-
21 type use and hire of passenger motor vehicles, and services
22 as authorized by section 3109 of title 5, United States
23 Code, \$379,837,000, of which \$75,551,000 shall remain
24 available until September 30, 2027: *Provided*, That not

1 to exceed \$7,180 shall be for official reception and rep-
2 resentation expenses.

3 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

4 For necessary expenses of the Federal Law Enforce-
5 ment Training Centers for procurement, construction, and
6 improvements, \$18,300,000, to remain available until Sep-
7 tember 30, 2030, for acquisition of necessary additional
8 real property and facilities, construction and ongoing
9 maintenance, facility improvements, and related expenses
10 of the Federal Law Enforcement Training Centers.

11 SCIENCE AND TECHNOLOGY DIRECTORATE

12 OPERATIONS AND SUPPORT

13 For necessary expenses of the Science and Tech-
14 nology Directorate for operations and support, including
15 the purchase or lease of not to exceed 5 vehicles,
16 \$352,802,000, of which \$201,183,000 shall remain avail-
17 able until September 30, 2027: *Provided*, That not to ex-
18 ceed \$10,000 shall be for official reception and representa-
19 tion expenses.

20 PROCUREMENT, CONSTRUCTION, AND IMPROVEMENTS

21 For necessary expenses of the Science and Tech-
22 nology Directorate for procurement, construction, and im-
23 provements, \$51,500,000, to remain available until Sep-
24 tember 30, 2030.

1 RESEARCH AND DEVELOPMENT

2 For necessary expenses of the Science and Tech-
3 nology Directorate for research and development,
4 \$426,904,000, to remain available until September 30,
5 2028.

6 ADMINISTRATIVE PROVISIONS

7 SEC. 401. (a) Notwithstanding any other provision
8 of law, funds otherwise made available to U.S. Citizenship
9 and Immigration Services may be used to acquire, operate,
10 equip, and dispose of up to 5 vehicles, for replacement
11 only, for areas where the Administrator of General Serv-
12 ices does not provide vehicles for lease.

13 (b) The Director of U.S. Citizenship and Immigration
14 Services may authorize employees who are assigned to
15 those areas to use such vehicles to travel between the em-
16 ployees' residences and places of employment.

17 SEC. 402. None of the funds appropriated or other-
18 wise made available to the Department of Homeland Secu-
19 rity by this Act or any other Act, including prior Acts and
20 laws other than appropriations Acts, may be used to proc-
21 ess or approve a competition under Office of Management
22 and Budget Circular A-76 for services provided by em-
23 ployees (including employees serving on a temporary or
24 term basis) of U.S. Citizenship and Immigration Services
25 of the Department of Homeland Security who are known

1 as Immigration Information Officers, Immigration Service
2 Analysts, Contact Representatives, Investigative Assist-
3 ants, or Immigration Services Officers.

4 SEC. 403. Notwithstanding any other provision of
5 law, any Federal funds made available to U.S. Citizenship
6 and Immigration Services may be used for the collection
7 and use of biometrics taken at a U.S. Citizenship and Im-
8 migration Services Application Support Center that is
9 overseen virtually by U.S. Citizenship and Immigration
10 Services personnel using appropriate technology.

11 SEC. 404. The Director of the Federal Law Enforce-
12 ment Training Centers is authorized to distribute funds
13 to Federal law enforcement agencies for expenses incurred
14 participating in training accreditation.

15 SEC. 405. The Federal Law Enforcement Training
16 Accreditation Board, including representatives from the
17 Federal law enforcement community and non-Federal ac-
18 creditation experts involved in law enforcement training,
19 shall lead the Federal law enforcement training accredita-
20 tion process to continue the implementation of measuring
21 and assessing the quality and effectiveness of Federal law
22 enforcement training programs, facilities, and instructors.

23 SEC. 406. (a) The Director of the Federal Law En-
24 forcement Training Centers may accept transfers to its
25 “Procurement, Construction, and Improvements” account

1 from Government agencies requesting the construction of
2 special use facilities, as authorized by the Economy Act
3 (31 U.S.C. 1535(b)).

4 (b) The Federal Law Enforcement Training Centers
5 shall maintain administrative control and ownership upon
6 completion of such facilities.

7 SEC. 407. The functions of the Federal Law Enforce-
8 ment Training Centers instructor staff shall be classified
9 as inherently governmental for purposes of the Federal
10 Activities Inventory Reform Act of 1998 (31 U.S.C. 501
11 note).

1 TITLE V
2 GENERAL PROVISIONS
3 (INCLUDING TRANSFERS AND RESCISSIONS OF FUNDS)

4 SEC. 501. No part of any appropriation contained in
5 this Act shall remain available for obligation beyond the
6 current fiscal year unless expressly so provided herein.

7 SEC. 502. Subject to the requirements of section 503
8 of this Act, the unexpended balances of prior appropria-
9 tions provided for activities in this Act may be transferred
10 to appropriation accounts for such activities established
11 pursuant to this Act, may be merged with funds in the
12 applicable established accounts, and thereafter may be ac-
13 counted for as one fund for the same time period as origi-
14 nally enacted.

15 SEC. 503. (a) None of the funds provided by this Act,
16 provided by previous appropriations Acts to the compo-
17 nents in or transferred to the Department of Homeland
18 Security that remain available for obligation or expendi-
19 ture in fiscal year 2026, or provided from any accounts
20 in the Treasury of the United States derived by the collec-
21 tion of fees available to the components funded by this
22 Act, shall be available for obligation or expenditure
23 through a reprogramming of funds that—

24 (1) creates or eliminates a program, project, or
25 activity, or increases funds for any program, project,

1 or activity for which funds have been denied or re-
2 stricted by the Congress;

3 (2) contracts out any function or activity pres-
4 ently performed by Federal employees or any new
5 function or activity proposed to be performed by
6 Federal employees in the President's budget pro-
7 posal for fiscal year 2026 for the Department of
8 Homeland Security;

9 (3) augments funding for existing programs,
10 projects, or activities in excess of \$5,000,000 or 10
11 percent, whichever is less;

12 (4) reduces funding for any program, project,
13 or activity, or numbers of personnel, by 10 percent
14 or more; or

15 (5) results from any general savings from a re-
16 duction in personnel that would result in a change
17 in funding levels for programs, projects, or activities
18 as approved by the Congress.

19 (b) Subsection (a) shall not apply if the Committees
20 on Appropriations of the House of Representatives and the
21 Senate are notified at least 30 days in advance of such
22 reprogramming.

23 (c) Up to 5 percent of any appropriation made avail-
24 able for the current fiscal year for the Department of
25 Homeland Security by this Act or provided by previous

1 appropriations Acts may be transferred between such ap-
2 propriations if the Committees on Appropriations of the
3 House of Representatives and the Senate are notified at
4 least 30 days in advance of such transfer, but no such
5 appropriation, except as otherwise specifically provided,
6 shall be increased by more than 10 percent by such trans-
7 fer.

8 (d) Notwithstanding subsections (a), (b), and (c), no
9 funds shall be reprogrammed within or transferred be-
10 tween appropriations—

11 (1) based upon an initial notification provided
12 after June 15, except in extraordinary circumstances
13 that imminently threaten the safety of human life or
14 the protection of property;

15 (2) to increase or decrease funding for grant
16 programs; or

17 (3) to create a program, project, or activity
18 pursuant to subsection (a)(1), including any new
19 function or requirement within any program, project,
20 or activity, not approved by Congress in the consid-
21 eration of the enactment of this Act.

22 (e) The notification thresholds and procedures set
23 forth in subsections (a), (b), (c), and (d) shall apply to
24 any use of deobligated balances of funds provided in pre-
25 vious Department of Homeland Security Appropriations

1 Acts that remain available for obligation in the current
2 year.

3 (f) Notwithstanding subsection (c), the Secretary of
4 Homeland Security may transfer to the fund established
5 by 8 U.S.C. 1101 note, up to \$20,000,000 from appro-
6 priations available to the Department of Homeland Secu-
7 rity: *Provided*, That the Secretary shall notify the Com-
8 mittees on Appropriations of the House of Representatives
9 and the Senate at least 5 days in advance of such transfer.

10 SEC. 504. (a) Section 504 of the Department of
11 Homeland Security Appropriations Act, 2017 (division F
12 of Public Law 115–31), related to the operations of a
13 working capital fund, shall apply with respect to funds
14 made available in this Act in the same manner as such
15 section applied to funds made available in that Act.

16 (b) Funds from such working capital fund may be
17 obligated and expended in anticipation of reimbursements
18 from components of the Department of Homeland Secu-
19 rity.

20 SEC. 505. (a) Except as otherwise specifically pro-
21 vided by law, not to exceed 50 percent of unobligated bal-
22 ances remaining available at the end of fiscal year 2026,
23 as recorded in the financial records at the time of a re-
24 programming notification, but not later than June 15,
25 2027, from appropriations for “Operations and Support”

1 for fiscal year 2026 in this Act shall remain available
2 through September 30, 2027, in the account and for the
3 purposes for which the appropriations were provided.

4 (b) Prior to the obligation of such funds, a notifica-
5 tion shall be submitted to the Committees on Appropria-
6 tions of the House of Representatives and the Senate in
7 accordance with section 503 of this Act.

8 SEC. 506. (a) Funds made available by this Act for
9 intelligence activities are deemed to be specifically author-
10 ized by the Congress for purposes of section 504 of the
11 National Security Act of 1947 (50 U.S.C. 414) during fis-
12 cal year 2026 until the enactment of an Act authorizing
13 intelligence activities for fiscal year 2026.

14 (b) Amounts described in subsection (a) made avail-
15 able for “Intelligence, Analysis, and Situational Aware-
16 ness—Operations and Support” that exceed the amounts
17 in such authorization for such account shall be transferred
18 to and merged with amounts made available under the
19 heading “Management Directorate—Operations and Sup-
20 port”.

21 (c) Prior to the obligation of any funds transferred
22 under subsection (b), the Undersecretary for Management
23 shall brief the Committees on Appropriations of the House
24 of Representatives and the Senate on a plan for the use
25 of such funds.

1 SEC. 507. (a) The Secretary of Homeland Security,
2 or the designee of the Secretary, shall notify the Commit-
3 tees on Appropriations of the House of Representatives
4 and the Senate at least three full business days in advance
5 of—

6 (1) making or awarding a grant allocation or
7 grant in excess of \$1,000,000 or a grant made from
8 the Disaster Relief Fund in excess of \$100,000;

9 (2) making or awarding a contract, other trans-
10 action agreement, or task or delivery order on a
11 multiple award contract, or to issue a letter of intent
12 totaling in excess of \$2,000,000;

13 (3) awarding a task or delivery order requiring
14 an obligation of funds in an amount greater than
15 \$5,000,000 from multi-year Department of Home-
16 land Security funds;

17 (4) making a sole-source grant award; or

18 (5) announcing publicly the intention to make
19 or award items under paragraph (1), (2), (3), or (4)
20 including a contract covered by the Federal Acquisi-
21 tion Regulation.

22 (b) If the Secretary of Homeland Security determines
23 that compliance with this section would pose a substantial
24 risk to human life, health, or safety, an award may be
25 made without notification, and the Secretary shall notify

1 the Committees on Appropriations of the House of Rep-
2 resentatives and the Senate not later than three full busi-
3 ness days after such an award is made or letter issued.

4 (c) A notification under this section—

5 (1) may not involve funds that are not available
6 for obligation; and

7 (2) shall include the amount of the award; the
8 fiscal year for which the funds for the award were
9 appropriated; the type of contract; and the account
10 from which the funds are being drawn.

11 SEC. 508. Notwithstanding any other provision of
12 law, no agency shall purchase, construct, or lease any ad-
13 ditional facilities, except within or contiguous to existing
14 locations, to be used for the purpose of conducting Federal
15 law enforcement training without advance notification to
16 the Committees on Appropriations of the House of Rep-
17 resentatives and the Senate, except that the Federal Law
18 Enforcement Training Centers is authorized to obtain the
19 temporary use of additional facilities by lease, contract,
20 or other agreement for training that cannot be accommo-
21 dated in existing Centers' facilities.

22 SEC. 509. None of the funds appropriated or other-
23 wise made available to the Department of Homeland Secu-
24 rity by this Act or any other Act, including prior Acts and
25 laws other than appropriations Acts, may be used for ex-

1 penses for any construction, repair, alteration, or acquisi-
2 tion project for which a prospectus otherwise required
3 under chapter 33 of title 40, United States Code, has not
4 been approved, except that necessary funds may be ex-
5 pended for each project for required expenses for the de-
6 velopment of a proposed prospectus.

7 SEC. 510. Sections 522 and 530 of the Department
8 of Homeland Security Appropriations Act, 2008 (division
9 E of Public Law 110–161; 121 Stat. 2073 and 2074) shall
10 apply with respect to funds made available in this Act in
11 the same manner as such sections applied to funds made
12 available in that Act.

13 SEC. 511. (a) None of the funds made available in
14 this Act may be used in contravention of the applicable
15 provisions of the Buy American Act.

16 (b) For purposes of subsection (a), the term “Buy
17 American Act” means chapter 83 of title 41, United
18 States Code.

19 SEC. 512. None of the funds made available in this
20 Act may be used to amend the oath of allegiance required
21 by section 337 of the Immigration and Nationality Act
22 (8 U.S.C. 1448).

23 SEC. 513. (a) None of the funds appropriated or oth-
24 erwise made available to the Department of Homeland Se-
25 curity by this Act or any other Act, including prior Acts

1 and laws other than appropriations Acts, may be made
2 available to carry out section 872 of the Homeland Secu-
3 rity Act of 2002 (6 U.S.C. 452) unless explicitly author-
4 ized by the Congress after the date of enactment of this
5 Act.

6 (b) Subsection (a) shall not apply to the use of the
7 authorities provided by such section 872—

8 (1) to allocate or reallocate the functions of the
9 Assistant Secretary for the Countering Weapons of
10 Mass Destruction Office to other offices and organi-
11 zational units within the Department consistent with
12 the “Countering Weapons of Mass Destruction”
13 table in the explanatory statement described in sec-
14 tion 553 of this Act; or

15 (2) to allocate or reallocate any other functions
16 of the Countering Weapons of Mass Destruction Of-
17 fice to other offices and organizational units within
18 the Department consistent with the “Countering
19 Weapons of Mass Destruction” table in the explana-
20 tory statement described in section 553 of this Act.

21 (c) Notwithstanding subsection (a), the Secretary
22 may transfer funds made available in prior appropriations
23 Acts to the Countering Weapons of Mass Destruction Of-
24 fice between any appropriations available to the Depart-

1 ment as necessary to carry out the purposes described in
2 subsection (b).

3 SEC. 514. None of the funds appropriated or other-
4 wise made available to the Department of Homeland Secu-
5 rity by this Act or any other Act, including prior Acts and
6 laws other than appropriations Acts, may be used for plan-
7 ning, testing, piloting, or developing a national identifica-
8 tion card.

9 SEC. 515. Any official that is required by this Act
10 to report or to certify to the Committees on Appropria-
11 tions of the House of Representatives and the Senate may
12 not delegate such authority to perform that act unless spe-
13 cifically authorized herein.

14 SEC. 516. None of the funds appropriated or other-
15 wise made available to the Department of Homeland Secu-
16 rity by this Act or any other Act, including prior Acts and
17 laws other than appropriations Acts, may be used for first-
18 class travel by the employees of agencies funded by this
19 Act in contravention of sections 301–10.122 through 301–
20 10.124 of title 41, Code of Federal Regulations.

21 SEC. 517. None of the funds made available in this
22 Act may be used to employ workers described in section
23 274A(h)(3) of the Immigration and Nationality Act (8
24 U.S.C. 1324a(h)(3)).

1 SEC. 518. Notwithstanding any other provision of
2 this Act, none of the funds appropriated or otherwise
3 made available by this Act may be used to pay award or
4 incentive fees for contractor performance that has been
5 judged to be below satisfactory performance or perform-
6 ance that does not meet the basic requirements of a con-
7 tract.

8 SEC. 519. (a) None of the funds appropriated or oth-
9 erwise made available to the Department of Homeland Se-
10 curity by this Act or any other Act, including prior Acts
11 and laws other than appropriations Acts, may be used to
12 maintain or establish a computer network unless such net-
13 work blocks the viewing, downloading, and exchanging of
14 pornography.

15 (b) Nothing in subsection (a) shall limit the use of
16 funds necessary for any Federal, State, tribal, territorial,
17 or local law enforcement agency or any other entity car-
18 rying out criminal investigations, prosecution, or adjudica-
19 tion activities.

20 SEC. 520. None of the funds appropriated or other-
21 wise made available to the Department of Homeland Secu-
22 rity by this Act or any other Act, including prior Acts and
23 laws other than appropriations Acts, may be used by a
24 Federal law enforcement officer to facilitate the transfer
25 of an operable firearm to an individual if the Federal law

1 enforcement officer knows or suspects that the individual
2 is an agent of a drug cartel unless law enforcement per-
3 sonnel of the United States continuously monitor or con-
4 trol the firearm at all times.

5 SEC. 521. (a) None of the funds made available in
6 this Act may be used to pay for the travel to or attendance
7 of more than 50 employees of a single component of the
8 Department of Homeland Security, who are stationed in
9 the United States, at a single international conference un-
10 less the Secretary of Homeland Security, or a designee,
11 determines that such attendance is in the national interest
12 and notifies the Committees on Appropriations of the
13 House of Representatives and the Senate within at least
14 10 days of that determination and the basis for that deter-
15 mination.

16 (b) For purposes of this section the term “inter-
17 national conference” shall mean a conference occurring
18 outside of the United States attended by representatives
19 of the United States Government and of foreign govern-
20 ments, international organizations, or nongovernmental
21 organizations.

22 (c) The total cost to the Department of Homeland
23 Security of any such conference shall not exceed \$500,000.

24 (d) Employees who attend a conference virtually
25 without travel away from their permanent duty station

1 within the United States shall not be counted for purposes
2 of this section, and the prohibition contained in this sec-
3 tion shall not apply to payments for the costs of attend-
4 ance for such employees.

5 SEC. 522. None of the funds appropriated or other-
6 wise made available to the Department of Homeland Secu-
7 rity by this Act or any other Act, including prior Acts and
8 laws other than appropriations Acts, may be used to reim-
9 burse any Federal department or agency for its participa-
10 tion in a National Special Security Event.

11 SEC. 523. (a) None of the funds appropriated or oth-
12 erwise made available to the Department of Homeland Se-
13 curity by this Act or any other Act, including prior Acts
14 and laws other than appropriations Acts, may be obligated
15 for the implementation of any structural pay reform or
16 the introduction of any new position classification that will
17 affect more than 100 full-time positions or costs more
18 than \$5,000,000 in a single year before the end of the
19 30-day period beginning on the date on which the Sec-
20 retary of Homeland Security submits to Congress a notifi-
21 cation that includes—

22 (1) the number of full-time positions affected by
23 such change;

1 (2) funding required for such change for the
2 current fiscal year and through the Future Years
3 Homeland Security Program;

4 (3) justification for such change; and

5 (4) for a structural pay reform, an analysis of
6 compensation alternatives to such change that were
7 considered by the Department.

8 (b) Subsection (a) shall not apply to such change if—

9 (1) it was proposed in the President’s budget
10 proposal for the fiscal year funded by this Act; and

11 (2) funds for such change have not been explic-
12 itly denied or restricted in this Act.

13 SEC. 524. (a) Any agency under the Department of
14 Homeland Security shall, subject to subsections (b) and
15 (c), post on the public website of that agency any report
16 required to be submitted by the Committees on Appropria-
17 tions of the House of Representatives and the Senate in
18 this Act, upon the determination by the head of the agency
19 that it shall serve the national interest.

20 (b) Subsection (a) shall not apply to a report if—

21 (1) the public posting of the report com-
22 promises homeland or national security; or

23 (2) the report contains proprietary information.

24 (c) The head of the agency posting such report shall
25 do so only after such report has been made available to

1 the Committees on Appropriations of the House of Rep-
2 resentatives and the Senate for not less than 45 days ex-
3 cept as otherwise specified in law.

4 (d) If the requirements of this section are not met,
5 the reprogramming and transfer authority provided in sec-
6 tion 503 of this Act shall be suspended until the require-
7 ments of subsection (a) are met.

8 SEC. 525. (a) Funding provided in this Act for “Op-
9 erations and Support” may be used for minor procure-
10 ment, construction, and improvements.

11 (b) For purposes of subsection (a), “minor” refers
12 to end items with a unit cost of \$250,000 or less for per-
13 sonal property, and \$4,000,000 or less for real property.

14 SEC. 526. The authority provided by section 532 of
15 the Department of Homeland Security Appropriations
16 Act, 2018 (Public Law 115–141) regarding primary and
17 secondary schooling of dependents shall continue in effect
18 during fiscal year 2026.

19 SEC. 527. (a) Except as provided in subsection (b),
20 none of the funds appropriated or otherwise made avail-
21 able to the Department of Homeland Security by this Act
22 or any other Act, including prior Acts and laws other than
23 appropriations Acts, may be used to place restraints on
24 a woman in the custody of the Department of Homeland
25 Security (including during transport, in a detention facil-

1 ity, or at an outside medical facility) who is pregnant or
2 in post-delivery recuperation.

3 (b) Subsection (a) shall not apply with respect to a
4 pregnant woman if—

5 (1) an appropriate official of the Department of
6 Homeland Security makes an individualized deter-
7 mination that the woman—

8 (A) is a serious flight risk, and such risk
9 cannot be prevented by other means; or

10 (B) poses an immediate and serious threat
11 to harm herself or others that cannot be pre-
12 vented by other means; or

13 (2) a medical professional responsible for the
14 care of the pregnant woman determines that the use
15 of therapeutic restraints is appropriate for the med-
16 ical safety of the woman.

17 (c) If a pregnant woman is restrained pursuant to
18 subsection (b), only the safest and least restrictive re-
19 straints, as determined by the appropriate medical profes-
20 sional treating the woman, may be used. In no case may
21 restraints be used on a woman who is in active labor or
22 delivery, and in no case may a pregnant woman be re-
23 strained in a face-down position with four-point restraints,
24 on her back, or in a restraint belt that constricts the area
25 of the pregnancy. A pregnant woman who is immobilized

1 by restraints shall be positioned, to the maximum extent
2 feasible, on her left side.

3 SEC. 528. (a) None of the funds appropriated or oth-
4 erwise made available to the Department of Homeland Se-
5 curity by this Act or any other Act, including prior Acts
6 and laws other than appropriations Acts, may be used to
7 destroy any document, recording, or other record per-
8 taining to any—

9 (1) death of;

10 (2) potential sexual assault or abuse per-
11 petrated against; or

12 (3) allegation of abuse, criminal activity, or dis-
13 ruption committed by an individual held in the cus-
14 tody of the Department of Homeland Security.

15 (b) The records referred to in subsection (a) shall be
16 made available, in accordance with applicable laws and
17 regulations, and Federal rules governing disclosure in liti-
18 gation, to an individual who has been charged with a
19 crime, been placed into segregation, or otherwise punished
20 as a result of an allegation described in paragraph (3),
21 upon the request of such individual.

22 SEC. 529. Section 519 of division F of Public Law
23 114–113, regarding a prohibition on funding for any posi-
24 tion designated as a Principal Federal Official, shall apply
25 with respect to any Federal funds in the same manner

1 as such section applied to funds made available in that
2 Act.

3 SEC. 530. (a) Not later than 10 days after the date
4 on which the budget of the President for a fiscal year is
5 submitted to Congress pursuant to section 1105(a) of title
6 31, United States Code, the Under Secretary for Manage-
7 ment of Homeland Security shall submit to the Commit-
8 tees on Appropriations of the House of Representatives
9 and the Senate a report on the unfunded priorities, for
10 the Department of Homeland Security and separately for
11 each departmental component, for which discretionary
12 funding would be classified as budget function 050.

13 (b) Each report under this section shall specify, for
14 each such unfunded priority—

15 (1) a summary description, including the objec-
16 tives to be achieved if such priority is funded
17 (whether in whole or in part);

18 (2) the description, including the objectives to
19 be achieved if such priority is funded (whether in
20 whole or in part);

21 (3) account information, including the following
22 (as applicable):

23 (A) appropriation account; and

24 (B) program, project, or activity name;

25 and

1 (4) the additional number of full-time or part-
2 time positions to be funded as part of such priority.

3 (c) In this section, the term “unfunded priority”, in
4 the case of a fiscal year, means a requirement that—

5 (1) is not funded in the budget referred to in
6 subsection (a);

7 (2) is necessary to fulfill a requirement associ-
8 ated with an operational or contingency plan for the
9 Department; and

10 (3) would have been recommended for funding
11 through the budget referred to in subsection (a) if—

12 (A) additional resources had been available
13 for the budget to fund the requirement;

14 (B) the requirement has emerged since the
15 budget was formulated; or

16 (C) the requirement is necessary to sustain
17 prior-year investments.

18 SEC. 531. (a) Not later than 10 days after a deter-
19 mination is made by the President to evaluate and initiate
20 protection under any authority for a former or retired
21 Government official or employee, or for an individual who,
22 during the duration of the directed protection, will become
23 a former or retired Government official or employee (re-
24 ferred to in this section as a “covered individual”), the
25 Secretary of Homeland Security shall submit a notifica-

1 tion to congressional leadership and the Committees on
2 Appropriations of the House of Representatives and the
3 Senate, the Committees on the Judiciary of the House of
4 Representatives and the Senate, the Committee on Home-
5 land Security of the House of Representatives, the Com-
6 mittee on Homeland Security and Governmental Affairs
7 of the Senate, and the Committee on Oversight and Re-
8 form of the House of Representatives (referred to in this
9 section as the “appropriate congressional committees”).

10 (b) Such notification may be submitted in classified
11 form, if necessary, and in consultation with the Director
12 of National Intelligence or the Director of the Federal Bu-
13 reau of Investigation, as appropriate, and shall include the
14 threat assessment, scope of the protection, and the antici-
15 pated cost and duration of such protection.

16 (c) Not later than 15 days before extending, or 30
17 days before terminating, protection for a covered indi-
18 vidual, the Secretary of Homeland Security shall submit
19 a notification regarding the extension or termination and
20 any change to the threat assessment to the congressional
21 leadership and the appropriate congressional committees.

22 (d) Not later than 45 days after the date of enact-
23 ment of this Act, and quarterly thereafter, the Secretary
24 shall submit a report to the congressional leadership and
25 the appropriate congressional committees, which may be

1 submitted in classified form, if necessary, detailing each
2 covered individual, and the scope and associated cost of
3 protection.

4 SEC. 532. (a) None of the funds provided to the De-
5 partment of Homeland Security in this or any prior Act
6 may be used by an agency to submit an initial project pro-
7 posal to the Technology Modernization Fund (as author-
8 ized by section 1078 of subtitle G of title X of the National
9 Defense Authorization Act for Fiscal Year 2018 (Public
10 Law 115–91)) unless, concurrent with the submission of
11 an initial project proposal to the Technology Moderniza-
12 tion Board, the head of the agency—

13 (1) notifies the Committees on Appropriations
14 of the House of Representatives and the Senate of
15 the proposed submission of the project proposal;

16 (2) submits to the Committees on Appropria-
17 tions a copy of the project proposal; and

18 (3) provides a detailed analysis of how the pro-
19 posed project funding would supplement or supplant
20 funding requested as part of the Department’s most
21 recent budget submission.

22 (b) None of the funds provided to the Department
23 of Homeland Security by the Technology Modernization
24 Fund shall be available for obligation until 15 days after
25 a report on such funds has been transmitted to the Com-

1 mittees on Appropriations of the House of Representatives
2 and the Senate.

3 (c) The report described in subsection (b) shall in-
4 clude—

5 (1) the full project proposal submitted to and
6 approved by the Fund's Technology Modernization
7 Board;

8 (2) the finalized interagency agreement between
9 the Department and the Fund including the
10 project's deliverables and repayment terms, as appli-
11 cable;

12 (3) a detailed analysis of how the project will
13 supplement or supplant existing funding available to
14 the Department for similar activities;

15 (4) a plan for how the Department will repay
16 the Fund, including specific planned funding
17 sources, as applicable; and

18 (5) other information as determined by the Sec-
19 retary.

20 SEC. 533. Within 60 days of any budget submission
21 for the Department of Homeland Security for fiscal year
22 2027 that assumes revenues or proposes a reduction from
23 the previous year based on user fees proposals that have
24 not been enacted into law prior to the submission of the
25 budget, the Secretary of Homeland Security shall provide

1 the Committees on Appropriations of the House of Rep-
2 resentatives and the Senate specific reductions in proposed
3 discretionary budget authority commensurate with the
4 revenues assumed in such proposals in the event that they
5 are not enacted prior to October 1, 2026.

6 SEC. 534. None of the funds made available by this
7 Act may be obligated or expended to implement the Arms
8 Trade Treaty until the Senate approves a resolution of
9 ratification for the Treaty.

10 SEC. 535. No Federal funds made available to the
11 Department of Homeland Security may be used to enter
12 into a procurement contract, memorandum of under-
13 standing, or cooperative agreement with, or make a grant
14 to, or provide a loan or guarantee to, any entity identified
15 under section 1260H of the William M. (Mac) Thornberry
16 National Defense Authorization Act for Fiscal Year 2021
17 (Public Law 116–283) or any subsidiary of such entity.

18 SEC. 536. None of the funds appropriated or other-
19 wise made available in this or any other Act may be used
20 to transfer, release, or assist in the transfer or release to
21 or within the United States, its territories, or possessions
22 Khalid Sheikh Mohammed or any other detainee who—
23 (1) is not a United States citizen or a member
24 of the Armed Forces of the United States; and

1 (2) is or was held on or after June 24, 2009,
2 at the United States Naval Station, Guantanamo
3 Bay, Cuba, by the Department of Defense.

4 SEC. 537. (a) The Secretary of Homeland Security
5 shall, on a monthly basis beginning immediately after the
6 date of enactment of this Act, develop estimates of the
7 number of migrants anticipated to arrive at the southwest
8 border of the United States.

9 (b) The Secretary shall ensure that, at a minimum,
10 the estimates developed pursuant to subsection (a)—

11 (1) cover the current fiscal year and the fol-
12 lowing fiscal year;

13 (2) include a breakout by demographic, to in-
14 clude single adults, family units, and unaccompanied
15 children;

16 (3) undergo an independent validation and
17 verification review;

18 (4) are used to inform policy planning and
19 budgeting processes within the Department of
20 Homeland Security; and

21 (5) are included in the budget materials sub-
22 mitted to Congress for each fiscal year beginning
23 after the date of enactment of this Act and in sup-
24 port of—

1 (A) the President's annual budget request
2 pursuant to section 1105 of title 31, United
3 States Code;

4 (B) any supplemental funding request sub-
5 mitted to Congress;

6 (C) any reprogramming and transfer noti-
7 fication pursuant to section 503 of this Act;
8 and

9 (D) such budget materials shall include—

10 (i) the most recent monthly estimates
11 developed pursuant to subsection (a);

8 propriations of the House of Representatives and the Sen-
9 ate.

10 SEC. 538. (a) The Secretary of Homeland Security

15 (b) The Secretary shall ensure that, at a minimum,
16 the estimates developed pursuant to subsection (a)—

18 lowing fiscal year;

19 (2) include a breakout by demographics, to in-
20 clude single adults and family units;

21 (3) undergo an independent validation and
22 verification review;

10 (b) are not provided for the purposes described, the re-

13 required estimates are provided to the Committees on Ap-
14 propriations of the House of Representatives and the Sen-
15 ate.

16 SEC. 539. (a) Prior to the Secretary of Homeland Se-
17 curity requesting assistance from the Department of De-
18 fense for border security operations, the Secretary shall
19 ensure that an alternatives analysis and cost-benefit anal-
20 ysis is conducted before such request is made, which shall
21 include an examination of obtaining such support through
22 other means.

23 (b) Not later than 30 days after the date on which
24 a request for assistance is made, the Secretary of Home-
25 land Security shall submit to the Committees on Appro-

1 priations of the House of Representatives and the Senate
2 a report detailing the types of support requested, the alter-
3 natives analysis and cost-benefit analysis described in sub-
4 section (a), and the operational impact to Department of
5 Homeland Security operations of any Department of De-
6 fense border security support requested by the Secretary.

7 (c) Not later than 30 days after the date on which
8 a request made for assistance is granted and quarterly
9 thereafter through the duration of such assistance, the
10 Secretary of Homeland Security shall submit to the Com-
11 mittees on Appropriations of the House of Representatives
12 and the Senate, a report detailing the assistance provided
13 and the operational impacts to border security operations.

14 SEC. 540. Funds made available in this Act or any
15 other Act for Operations and Support may be used for
16 the necessary expenses of providing an employee emer-
17 gency back-up care program.

18 SEC. 541. (a) If the reporting requirement set forth
19 in paragraph (2) under the heading “Federal Emergency
20 Management Agency—Disaster Relief Fund” in the De-
21 partment of Homeland Security Appropriations Act, 2015
22 (Public Law 114–4), as applied in this fiscal year by sec-
23 tion 306 of this Act, is not submitted to the Committees
24 on Appropriations of the House of Representatives and the
25 Senate and published on the Agency’s website not later

1 than the fifth business day of the applicable month, the
2 amount made available for “Office of the Secretary and
3 Executive Management—Operations and Support—Man-
4 agement and Oversight” shall be reduced by \$100,000 for
5 each day such report is not submitted and published on
6 the Agency’s website.

7 (b) During any period in which the total number of
8 requests for reimbursement for a covered expense for indi-
9 vidual assistance or public assistance related to emergency
10 (42 U.S.C. 5122(1)) or major disaster (42 U.S.C.
11 5122(2)) declarations under the Robert T. Stafford Dis-
12 aster Relief and Emergency Assistance Act (42 U.S.C.
13 5121 et seq.) that the Department of Homeland Security
14 has been considering under final review for greater than
15 60 days exceeds 500, the amount made available for “Of-
16 fice of the Secretary and Executive Management—Oper-
17 ations and Support—Management and Oversight” shall be
18 reduced by \$100,000 for each day during such period on
19 which the cumulative total of requests over 60 days in
20 final review exceeds 500.

21 (c) Subsection (b) shall not apply if the balance of
22 funding for the Disaster Relief Fund is sufficient only for
23 the purpose of obligating funds for activities determined
24 to be lifesaving or life-sustaining.

1 SEC. 542. Section 16005(c) of title VI of division B
2 of the Coronavirus Aid, Relief, and Economic Security Act
3 (Public Law 116–136) shall be applied as if the language
4 read as follows: “Subsection (a) shall apply until Sep-
5 tember 30, 2026.”.

6 SEC. 543. The levels for appropriations accounts
7 specified for classified programs in this Act shall conform
8 to the direction included in the classified annex accom-
9 panying this Act and shall be implemented in a manner
10 consistent with section 544.

11 SEC. 544. Upon a determination by the Director of
12 National Intelligence that such action is necessary and in
13 the national interest, the Director may, with the approval
14 of the Secretary of Homeland Security and the Director
15 of the Office of Management and Budget, transfer
16 amounts for the National Intelligence Program consistent
17 with the percentage caps specified in section 503(c): *Pro-*
18 *vided*, That such authority to transfer may not be used
19 unless for higher priority items, based on unforeseen intel-
20 ligence requirements, than those for which originally ap-
21 propriated and in no case where the item for which funds
22 are requested has been denied by the Congress: *Provided*
23 *further*, That a request for any transfer of funds using
24 authority provided in this section shall be made consistent
25 with the requirements of section 503(d)(1).

1 SEC. 545. Within seven days of the date of enactment
2 of this Act, and quarterly thereafter, the Department shall
3 submit to the Committees on Appropriation of the House
4 of Representatives and the Senate—

5 (1) an obligation plan by program, project, or
6 activity for each component receiving funds from
7 Public Law 119–21;

8 (2) estimated fee collections for each component
9 collecting new or enhanced fees authorized by Public
10 Law 119–21, delineated by collections that a compo-
11 nent will retain and collections that a component will
12 remit to other agencies or the Treasury; and

13 (3) an obligation plan by program, project, or
14 activity for fee collections identified in paragraph (2)
15 as being retained by a component within the Depart-
16 ment.

17 SEC. 546. (a) None of the funds appropriated or oth-
18 erwise made available to the Department of Homeland Se-
19 curity by this Act or any other Act, including prior Acts
20 and laws other than appropriations Acts, may be used to
21 prevent any of the following persons from entering, for
22 the purpose of conducting oversight, any facility operated
23 by or for the Department of Homeland Security used to
24 detain or otherwise house aliens, or to make any tem-
25 porary modification at any such facility that in any way

1 alters what is observed by a visiting Member of Congress
2 or such designated employee, compared to what would be
3 observed in the absence of such modification:

4 (1) A Member of Congress.

5 (2) An employee of the United States House of
6 Representatives or the United States Senate des-
7 igned by such a Member for the purposes of this
8 section.

9 (b) Nothing in this section may be construed to re-
10 quire a Member of Congress to provide prior notice of the
11 intent to enter a facility described in subsection (a) for
12 the purpose of conducting oversight.

13 (c) With respect to individuals described in subsection
14 (a)(2), the Department of Homeland Security may require
15 that a request be made at least 24 hours in advance of
16 an intent to enter a facility described in subsection (a).

17 SEC. 547. In addition to amounts otherwise made
18 available for such purposes, there is appropriated
19 \$30,000,000, for an additional amount for “The Judici-
20 ary—Supreme Court of the United States—Salaries and
21 Expenses”, to remain available until September 30, 2028:
22 *Provided*, That amounts made available pursuant to this
23 section shall be subject to the same authorities and condi-
24 tions as if such amounts were provided under the heading
25 “The Judiciary—Supreme Court of the United States—

1 Salaries and Expenses” in the Financial Services and
2 General Government Appropriations Act, 2026.

3 SEC. 548. There is appropriated \$140,000,000 for an
4 additional amount for “Department of Transportation—
5 Federal Aviation Administration—Operations” for air
6 traffic organization activities, to remain available until
7 September 30, 2027: *Provided*, That the Administrator of
8 the Federal Aviation Administration shall only use such
9 amounts to provide a rate of pay increase for calendar
10 year 2026 of 3.8 percent, for air traffic controllers, as de-
11 fined by section 2109(1)(A) of title 5, United States Code,
12 and air traffic controller supervisors or managers who are
13 not covered under such section, but who manage air traf-
14 fic: *Provided further*, That such adjustment shall be imple-
15 mented for all such employees only to the extent the Ad-
16 ministrator determines, in his sole discretion, that im-
17 provements in workforce scheduling, staffing utilization,
18 or other operational efficiencies are achieved that con-
19 tribute to addressing workforce shortfalls and enhancing
20 aviation safety: *Provided further*, That if the Adminis-
21 trator makes such determination, then such adjustment
22 shall be effective the first pay period beginning after Janu-
23 ary 1, 2026: *Provided further*, That amounts provided by
24 this section shall be subject to the same authorities and

1 conditions as if such amounts were provided by the De-
2 partment of Transportation Appropriations Act, 2026.

3 SEC. 549. (a) Of the total amount provided under the
4 heading “Cybersecurity and Infrastructure Security Agen-
5 cy—Operations and Support”, \$99,750,000 shall be de-
6 rived by transfer from the unobligated balances of
7 amounts previously appropriated under the heading “Cy-
8 bersecurity and Infrastructure Security Agency—Cyberse-
9 curity Response and Recovery Fund” in division J of the
10 Infrastructure Investment and Jobs Act (Public Law 117–
11 58).

12 (b) Amounts derived by transfer pursuant to this sec-
13 tion shall continue to be treated as amounts specified in
14 section 103(b) of division A of Public Law 118–5.

17 ment of Homeland Security, the following funds are here-
18 by rescinded from the following accounts and programs
19 in the specified amounts: *Provided*, That no amounts may

22 current resolution on the budget or the Balanced Budget
23 and Emergency Deficit Control Act of 1985:

16 SEC. 553. The explanatory statement regarding this
17 Act printed in the House of Representatives section of the
18 Congressional Record on January 22, 2026, and sub-
19 mitted by the chair of the Committee on the Appropria-
20 tions of the House, shall have the same effect with respect
21 to the allocation of funds and implementation of this Act
22 as if it were a joint explanatory statement of a committee
23 of conference, except that the contents printed under the
24 headings “U.S. Customs and Border Protection” and
25 “U.S. Immigration and Customs Enforcement” and the

1 amounts printed under such headings in the “Department
2 of Homeland Security Appropriations Act, 2026” table
3 shall have no force or effect for purposes of this Act.

4 This Act may be cited as the “Department of Home-
5 land Security Appropriations Act, 2026”.
